Notice is hereby given that the Board of Directors for the Clearwater Underground Water Conservation District will conduct a hearing on the Application for Operating Permit, Permit Amendment, and Drilling Permits described below at 1:30 p.m. Tuesday, September 9, 2014, at 700 Kennedy Court, Belton, Texas, in compliance with the Texas Open Meetings Act.

A person wishing to submit a Contested Case Hearing Request who is unable to appear at the hearing on the date and time set forth above must also file a motion for continuance with CUWCD demonstrating good cause for the inability to appear.
