

**NOTICE OF PERMIT HEARING OF THE

Notice is hereby given that the Board of Directors for the Clearwater Underground Water Conservation District will conduct a hearing on the Application for Operating Permit, Permit Amendment, and Drilling Permits described below at 1:30 p.m. April 8, 2015, at 700 Kennedy Court, Belton, Texas, in compliance with the Texas Open Meetings Act.
