

**NOTICE OF PERMIT HEARING OF THE

Notice is hereby given that the Board of Directors for the Clearwater Underground Water Conservation District will conduct a hearing on the Applications for Permits as described below at 1:30 p.m. on Friday 19, 2016 in the Clearwater UWCD Board Room located at 700 Kennedy Court, Belton, Texas, in compliance with the Texas Open Meetings Act.
