The Board of Directors of the Clearwater Underground Water Conservation District met in a regular session, open to the public, after due notice, at the Clearwater Underground Water Conservation District, located at 700 Kennedy Court, Belton, Texas, within the boundaries of the District, on the 25th day of August 2022, whereupon the roll was called of the members of the Board of Directors, to wit:

Five (5) of the five (5) Board members were present, thus constituting a quorum.

WHEREUPON, among other business conducted by the Board, Director David Cole introduced the Order set out below and moved for its adoption, which motion was seconded by Director Scott Brooks and, after full discussion and the question being put to the Board of Directors, said motion was carried by the following vote:

“Aye”: 3 ; “No”: 2 ; “Abstained”: 0 ; “Absent”: 0 .

The Order thus adopted is as follows:

WHEREAS, the Board of Directors was authorized by applicable statutory law to levy a sufficient tax to cover all maintenance and operation expenses of the District;

WHEREAS, the Board of Directors reviewed and approved its budget for its fiscal year October 1, 2022, through September 30, 2023, and determined what tax rate should be set to meet such budget requirements;

WHEREAS, the appraisal roll of the District for 2022 has been prepared and certified by the Tax Appraisal District of Bell County and submitted to the District's tax collector; and

NOW, THEREFORE, BE IT ORDERED BY THE BOARD OF DIRECTORS OF THE CLEARWATER UNDERGROUND WATER CONSERVATION DISTRICT THAT:

I.

The operation and maintenance tax rate for tax year 2022 shall be \$0.002708 per one hundred dollars (\$100) of assessed valuation. Be it known that this 2022 tax rate is less than last year's tax rate at \$0.00310 per \$100 of assessed valuation, but this rate will increase total taxes in Clearwater by 5.1%, or 9¢ per year on the average appraised value of a residence at \$219,528.00.

THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.

The Bell County Tax Assessor and Collector shall take all steps necessary and authorized by the law to collect taxes as owed pursuant to this order. Said taxes shall be levied, assessed and collected at the rate of \$0.002708 per \$100 valuation for 2022 as provided for in the District's enabling act; Chapters 36 Texas Groundwater Water Code, as applicable; and all other applicable laws.

II.

The Board President or Vice President are authorized to execute, and the Secretary or any Assistant Secretary to attest, this order on behalf of the Board of Directors.


