Notice is hereby given that the Board of Directors for the Clearwater Underground Water Conservation District will be accepting Applications for the Director-At-Large Position currently vacated by the resignation by Mr. R David Cole on January 4, 2023. Mr. Cole was reelected to the At-Large Director position recently and was unopposed for a four-year term ending in 2026. Mr. Cole as served on the board continuously since 2012 during which he was reelected for three full four-year terms office.

The Board of Directors formally accepted his resignation on January 11, 2023, thus by Board Action directed General Manager to provide public notice that applications for the position can be made and accepted immediately and until the close of business on February 9, 2023.

Applications should include a letter of intent stating your desire to serve and your qualifications for the position. Applicants shall also include a current resume. Applicants shall reside in Bell County and shall be registered voters in Bell County. 
